- 8 HIGHWAYS, RIGHTS OF WAY & ALLIED MATTERS
- **8.1 Highway Issues** Lane from Washpool Lane to stream at the bottom needs vegetation clearance. Clerk to report to BANES.

8.2 Amendment of Route on Definitive Map of BA11/15 Footpath

This is progressing.

- **8.5** Crab Apple Tyning Lane Designation This is a class 4 road and is therefore the responsibility of highways.
- 8.6 Englishcombe Road/Padleigh Hill Addresses Some of these addressed on the electoral roll are incorrect.
- **8.7 Clean Air Zone Consultation**. This consultation which runs until 20 October is the final one before implementation.
- 9 Millstream and Wheelwrights Workshop and Orchard Committee Report The subcommittee has not met since the last parish council meeting but is scheduled to do so in the near future. Agenda items will include plans for 2020 and further wildflower seeding of prepared areas at the north end of the site and possible tree planting. A memorial tree needs to be replaced as a matter of urgency. Millstream paths and The Orchard have been mown on a regular basis and are in good order with the exception of the path between Owl Bridge and the stream crossing down from the pond. It has not been possible to get the ride on mowers into this area another item for the MWWO meeting agenda. Recent high winds have caused damage to one apple tree and a willow, the latter and the path above have been dealt with by the parish council's PROW contractor involving some 5-6 hours work. The area previously cleared of trees at the front of Millstream was seeded with Meadow Mania Meadow Mix earlier this year and has produced a good selection of wildflowers, but comfrey has caused a problem. During the summer reasonable quantities and varieties of butterflies and dragonflies have been seen, and the bees in the Orchard are thriving.
- **10 Parish Newsletter and Website** The latest issue has recently been published and the deadline for the December issue is November 18. The website is now fully transferred to the parish council and has been updated with the latest news
- 11 District Councillor's Report In response to a request for an update from Cllr Huggett Cllr McCabe reported that the travellers sites considered and rejected for this use will stay rejected for a long time.
- 12 Reports by Clerk/Councillors/Chairman Cllr Hancock reported on first wedding at the chapel for a very long time.

Planning permission granted 15 August 2019 (subject to conditions and s.106) for 'Phase 1' of Sulis Down development comprising:

- 171 homes
- 68 (40%) affordable 51 Social Rent/17 Intermediate
- 6 flats for people with learning disabilities, 12 for elderly
- All vehicle access from Combe Hay Lane
- S.106 includes:
 - financial contributions including Education (Primary school places); Odd Down P&R pedestrian link:
 construction training
 - obligations to carry out works to Wansdyke; provision of allotments and open space*; provision of affordable homes; provision of pedestrian links; on and off-site ecological works (bat barns); landscape management scheme; safeguarded access to Sulis Manor
- Start on site late 2019/early 2020?
- * Parish Council have concerns about provision of allotments and management of the open space. A mechanism for provision, funding and management has been included in the s.106.

Plans for Future Development?

- Hignett Family Trust are promoting a masterplan for up to 800 homes
- Submitted as response to Local Plan process
- Access proposed from Combe Hay Lane and Midford Road (Cross Keys junction)
- · Includes development on land currently in the Green Belt

Proposals are contrary to Adopted Core Strategy Policy B3a ('around 300' homes but not a cap on development if all placemaking principles can be met, and vehicular access only from Combe Hay Lane)
